5. To create a forum for information exchange and dissemination among its members through electronic and print media; publications, conferences and workshops or seminars.
6. To participate in decision making process with other stakeholders within the Kenyan Ministry of Health on improvement of health service delivery when necessary.
7. To sustain a harmonious working relationship between Medical Laboratory Officers and/or Scientists and other healthcare professionals.
8. To affiliate, cooperate, subscribe or liaise with other societies, unions, associations, organizations or bodies within, or outside, the Republic of Kenya having objectives fully, or partly, similar to the objectives or

some of the objectives of the Society.

9. To represent Medical Laboratory Officers in any legal matter that is directly or indirectly affecting their practice.

What are eligibility criteria for one to become a member of LMSK?

1. Medical Laboratory Practitioners with a BSc degree (both direct entry and upgraders), with or without an MSc and/or a PhD.
2. Lecturers and Tutors of Medical Laboratory Science who are regulated and licensed by the Kenya Medical Laboratory Technicians and Technologists Board (KMLTTB).
3. MSc students who by practice are regulated by the Kenya Medical Laboratory Technicians and Technologists Board (KMLTTB).
4. BSc students of Medical Laboratory Science undergoing undergraduate training in Medical Laboratory Science and are indexed by KMLTTB.

Which categories of membership do we have?

1. Ordinary Membership:

Open to all with the qualifications described in 1, 2 & 3 under the [eligibility criteria](#) above.

2. Company Membership:

Shall be awarded by the National Executive Council to Vendors/Suppliers of In vitro Medical Diagnostic Devices and Diagnostic Reagents on agreeable terms that confer benefits to the company.

3. Honorary Membership:

Shall be conferred upon a member in exceptional circumstances by the National Executive Council.

4. Associate Membership:

Open to students undertaking a Bachelor's degree in Medical Laboratory Sciences and/or Technology who are KMLTTB indexed.

What are our membership and subscription fees and methods of payment?

For ordinary category of membership, membership fee is Ksh 750 payable once while our subscription fee is Ksh 300 payable every month.

For associate membership category, students pay Ksh 200 membership fee payable once and are exempted from monthly subscription until such a time they will upgrade their membership to ordinary level post-graduation.

How does one register?

1.  - d. Enter amount of **Ksh 1050** (inclusive of registration fee and first month subscription fee) or **Ksh 200** for associate membership or agreeable fee for company membership.
